1. Welcome

Vice Chairman Stuart Mills welcomed everyone to the meeting including Foundation Scotland and Scottish Power representatives and the three members of the public from the district.

2. SPR Halsary Windfarm Fund discussion - Scottish Power Rep: Craig Brown

This part of the meeting was closed to public, a discussion on the Halsary Windfarm Fund Due Diligence Statement took place – HDCC Chairman had concerns on signing the Statement due to the content and asking matters of privacy of the members. Craig Brown Scottish Power understood the concerns but declared the position of Scottish Power and this was part of every Fund and a standard they sent out and had to be met, though he had cases of concerns arisen before. Following further discussions, it was decided that Chairman Stuart Mills would prepare a statement of what he felt he could sign and would email this to Craig Brown for approval. If approval was met the Statement would be signed at the next meeting. This was felt a compromise on both sides. Eilidh Gunn and Craig Brown left the meeting and the members of the pubic rejoined.

As this was not on a priority list the Chairman will write to HC Head of Transport to report this.
